Predictive Services Discussion:

Northeasterly Santa Ana winds gusting to 50 mph are expected across southern California today and tonight, with relative humidity as low as 7% and poor overnight recovery. Scattered showers will continue in the Colorado Rockies and New Mexico, with snow above 6,000 to 7,000 feet. A fast-moving cold front will move into the Northwest, northern Rockies, and northern Great Basin today and tonight bringing light to moderate precipitation, with snow above 4,000 to 5,000 feet. Downslope westerly winds gusting to 50 mph will develop ahead of the front east of the Divide in Montana and Wyoming. A strong cold front will bring widespread wetting rain to the central/southern Plains and Mid/Upper Mississippi Valley. Strong to severe thunderstorms are expected ahead of the front across much of Missouri into western Arkansas, eastern Oklahoma, and east Texas. Dry conditions are expected in the Appalachians to East Coast, with temperatures warming closer to normal.
