Predictive Services Discussion:

An upper-level low will slowly move into Arizona, with isolated showers and from the Transverse and Peninsular Ranges of southern California into the southern Great Basin and northern Arizona. A cold front will move into the Northwest and northern Rockies from Canada with locally breezy westerly winds of 10-20 mph gusting 25-35 mph with the lowest relative humidity across Wyoming. Above normal temperatures will continue on the Front Range into the High Plains with minimum RH of 8-25% along with locally breezy south winds, strongest over the Texas/Oklahoma panhandles. However, moisture is expected to pool from northeast New Mexico into central Kansas with scattered showers and thunderstorms. Drier air will spread back into the central Appalachians and Upper Ohio Valley with minimum relative humidity as low as 25%. However, scattered showers and isolated thunderstorms are expected to move into portions of the Great Lakes and New England. Scattered showers and isolated thunderstorms are likely across portions of the Mid-Mississippi Valley, as well. Dry conditions are forecast for much of the Southeast, but a seasonably humid airmass is in place keeping minimum relative humidity above 40%, although portions of the Tennessee Valley may drop as low as 30%.
